
Requesting New Banner Funds from Controller's Office

Policy 3600: Funds Handling & Deposit of State/Local Funds

The Office of the University Bursar is committed to the fiscal stewardship of university funds to prevent mishandling of state and local funds, to safeguard against loss, and to protect employees. The procedures for funds handling are defined in <u>Policy 3600: Funds Handling and Deposit of State and Local Funds</u> to ensure proper handling and recording of university revenues whether a collection point is a regular, casual, or one-time basis funds handler.

To continue to achieve this goal, the Bursar's Office has updated Policy No. 3600 to define overall guidelines and assist departments with implementing these guidelines in Departments and units must utilize Bursar approved payment daily operations. channels where feasible to reduce or eliminate the need to handle funds. Approved payment channels include billing and collection through the university Accounts Receivable system, university preferred payment gateways for accepting payment cards and electronic checks, vendors paying by ACH or wire, and remittance of payments directly to the Bursar's Office for processing in lieu of mailing to the department or unit. Implementation of internal controls ensures funds received are appropriately secured, deposited, and recorded in the university's financial systems in a timely manner. Policy revisions include updated guidelines on the amount of cumulative receipts necessary to require a deposit and the appropriate safeguards to secure funds until deposited. Departments or units that collect funds on a regular basis should continue to make deposits daily and must have a Bursar approved funds handling plan. Casual or one-time collectors are required to meet minimum procedures as outlined in Policy No. 3600.

Training courses for the university cashiering system, CASHNet, and Funds Handling are both available online through Canvas. Resources are available on the Bursar website for training and policy requirements. The updated Policy 3600: Funds Handling and Deposit of State and Local Funds is also available on the Bursar website for review. 
Deactivation of Infrequently Used Expenditure Account Codes

To simplify the process for selecting an account code for an expenditure, the Controller's Office performed an analysis of account code use for the past five fiscal years. The review concentrated on account codes with little to no use from both a dollar and transaction count perspective, and preserved special purpose account codes with infrequent use. Approximately 150 account codes were deactivated and users can use Schedule A below to learn about deactivated codes and the suggested alternative code.

In the near term, our website will be refreshed to reflect these changes.
